# Flush feeding: An effective feeding practice in sheep farming



**Two aspects that can have a major impact on the effectivity and profit of sheep farming, are an increase in conception rate and fecundity of the breeding flock. Flush feeding of sheep is a feeding practice that can be used, under certain circumstances, to increase the lambing percentage and profitability of a sheep farm.**

It is well known that animal condition plays a vital role at the start of the breeding season. Nutrition (especially flush feeding) during this phase has an important objective – to ensure that the greatest number of ewes reach oestrus, that ovulation rate (ovum secretion) is maximised, and that most ova are fertilised, implanted and developed into viable foetuses to maximise lambing percentage.

## **Adjustment in nutrition**

Flush feeding is the term used to describe an adjustment in the level of nutrition of ewes (and rams) before the start of the breeding season, with the aim of increasing the condition score and weight of the animals.

Ewes normally get little to no supplements for a period prior to breeding which may cause weight loss. Normally, before breeding, ewes move to better quality grazing and given an additional flush lick three weeks prior to mating to quickly regain their weight lost. However, research showed that ovulation and conception rates decrease when ewes lose excessive weight shortly before the flush feeding phase and should be avoided at all costs.

Research indicated that the level of nutrition three weeks prior to breeding only has a significant impact if the ewes are not in optimal condition. The goal should be to get ewes into ideal condition (condition score or CS of 3,5) during breeding to ensure an optimal ovulation rate, and thus a high lambing percentage. In addition, if ewes gain weight during breeding period, they are more likely to produce twins than those that maintain or lose weight.

## **Higher lambing percentage**

An increase in ovulation rate is already noticeable when ewes start on flush feeding four days prior to breeding. However, best results are observed in ewes that start with flush feeding at least 21 days prior to ovulation, which is then continued for the duration of the mating period. A good rule of thumb is for lambing percentage to increase by 1,5% for each kilogram of additional weight gain during the breeding period when condition scores are on the lower end.

Ewes in good condition during breeding require less supplementation during mid and late gestation, and especially during lactation, as the ewe can use her body fat reserves as energy. It is

therefore of paramount importance that profitable sheep farming enterprises keep their breeding ewes in the desirable body condition (CS 3,5) during breeding.

### Sperm production in rams

Do not forget the contribution rams make towards ensuring a high lambing percentage. Flush feeding can help maximise testes size/volume as well as sperm production. Good nutrition for a period of at least two months prior to the start of the breeding season can double sperm production. Be careful of feeding excessive amounts of grain to rams (over conditioning), as it can adversely affect fertility (sperm quality) due to excessive fat deposits in the scrotum, which also limits heat exchange.

Breeding rams should receive well balanced protein/energy rations, especially with a higher level of bypass protein, to maximise testes growth and sperm production, as roughly 50% of the dry sperm material consists of protein.

For optimum results, make sure ewes and rams are in ideal condition before start of the breeding season. Flush feeding is a helpful feeding practice for sheep that to ensure optimal CS and weight gain before and during the breeding period, thereby maximising lambing percentage on farm.





# Update on Foot-and-Mouth in the Eastern Cape

## Update on Foot-and-Mouth in the Eastern Cape:

### Status of FMD in the Eastern Cape:

#### Kouga & Koukamma:

No new cases have been reported, and no positive results have been received since the 19th of September 2024 (serologically positive). There are 37 positive farms (made up of 6 beef farms and 31 dairy farms) and 39 negative-vaccinated farms within the DMA. Of the 37 positive farms, 26 have reached Day 0.

56 farms in the DMA are naïve and not under quarantine, which includes 15 000 animals that are naïve and unvaccinated.

Surveillance testing was done during December on naïve farms, the State Vet is still awaiting these results. These results as well as an additional round of intensified surveillance testing (which would include a combination of clinical and serology surveillance) have to be done within the DMA to prove that there is no circulating virus within the DMA, mainly on the negative farms in the DMA, as these farms will be classified as sentinel farms. It was suggested that cows born after the last reported case should also be considered in the surveillance. The National Department will consider lifting the DMA once this has been achieved and negative results are obtained from the surveillance testing.

This would be the first step towards lifting the DMA, as agreed to by the National Department.

Once the DMA is lifted, the farms under quarantine (positive-vaccinated and naïve-vaccinated farms) will remain under quarantine, with restrictions, until the quarantine has been lifted. The State Vet has cautioned the rush of lifting the DMA, as the risk is still high.

The surveillance planning and steps to lifting the DMA will be taken to the Technical and Trade Committee and National for guidance.

For the lifting of quarantine, Dr Maja referred to the WHOA standards with regards to the closing of an outbreak, and therefore lifting of quarantine on individual farms is based on the Terrestrial Animal Health Code, which states a quarantine period of a minimum of 12 months.

Restrictions outside the DMA: The Department is considering doing away with the restrictions outside the DMA, they want to do a bit more surveillance in this area first. Some surveillance was done during December, and are awaiting the results before making a decision. The outcome will be looked at and considered if more surveillance should be done before the restrictions are removed.

#### East London:

6 months post Day 0 has been reached in December 2024, therefore they can now slaughter at abattoirs outside of Claremont. They have been approved to send animals to slaughter at another abattoir from January 2025.

## **Matters arising:**

### **Emergency slaughters, cull/weaner cows and calves movement to a abattoir:**

Four farms have already been approved to slaughter at any abattoir (that does not have export status) outside the DMA but within the State Vet area. There is currently a capacity problem from Veterinary Services which cannot keep up with the demand to inspect and seal trucks. Solutions to this are being sought by Veterinary Services, and they are pulling officials from Grahamstown and Graaff-Reinet to assist.

Farms that have reached 6 months post Day 0 can apply to slaughter at other registered abattoirs. Approval must be sort for slaughter in other abattoirs for each abattoir that will be used. The 39 farms vaccinated during the mass vaccination, have reached Day 0 as of last week Friday, therefore there will be a large number of slaughter applications coming through to the Department which will increase the demand for the inspecting and sealing of trucks to slaughter.

### **Movement to Western Cape:**

The Western Cape Director advised that movement of cattle and sheep to the Western Cape from outside the DMA will be approved, however the State Vet at destination needs to be informed. Once this has happened, producers can move said animals to the Western Cape under the permit process (through Agri EC) after the Eastern Cape has been notified and received approval from the Western Cape State Vet for the area of Destination. The 28-day isolation rule will be enforced and remain in place.

### **Animals to Auction – Outside the DMA:**

Currently, as it stands no animals from Kouga and Koukamma Local Municipal areas are not allowed to move to an auction. Movement to an auction for animals outside the DMA will now be considered but they must be moved under the permit system to auction. These movement applications must go through the permit system done through Agri EC.

An auction facility outside the DMA will also be considered but the pin coordinates first need to be sent to Dr Strydom for approval first before anything can take place. All animals moving to the auction facility outside the DMA will need to

move under permit. No animals from within the DMA will be allowed.

For the movement of animals from the auction to the destination, a declaration will have to be signed attesting to the 28-day quarantine period on the farm of the destination. Alternatively an “open permit” could be provided to the auctioneers for those registered to take part in the auction which the auctioneers can fill in the final tag numbers and sign off for movement to destination. The auctioneers are to provide Dr Strydom with the number of animals at auction and the number of animals purchased for reconciliation purposes.

### **Branding of Animals:**

From June to September 28 farms were branded totaling 25 195 animals branded by State Officials. 7 farms branded themselves, totaling 8 851 animals.

The branding irons donated by RMIS have been used to brand 6 farms so far since receiving the irons, an update on how many animals have been branded is still to be received.

There is a branding operation planned from the 27th of January to the 7th of February, this depends on accommodation for officials and gas for cylinders as the gas is running very low.

Currently, gas and gas bottles are a limiting factor.

It is important that all animals are branded before the DMA is lifted.

### **Movement Permits:**

Movement permits for movement within and outside the DMA and within the Kouga and Koukamma Local Municipalities currently remain in place and farmers are encouraged to continue using the system for movement.





# Nuwe inisiatief bring hoop vir Wes-Kaapse landbougemeenskappe

**Landbouwerkers in die Wes-Kaap het nuwe rede tot hoop nadat die Landelike Stigting, 'n organisasie wat daarop gemik is om plaaslike gemeenskappe se lewensomstandighede deur middel van sport en onderwys te verbeter, amptelik bekendgestel is.**

Tydens die geleentheid wat Donderdag plaasgevind het, is 'n samewerkingsooreenkoms met die Landbou Akademie in Bloemfontein, asook met die private landboukollege International Agricultural Academy for Africa College (I3A) aangekondig. Dié vennootskap het ten doel om satellietkampusse van I3A in Kaapstad – en in die groter Wes-Kaap – te vestig.

Volgens Fanie Cronjé, uitvoerende hoof van die Landelike Stigting, is die samewerkingsooreenkoms 'n deurslaggewende stap om lewensomstandighede vir landbouwerkers in dié provinsie te verbeter.

“Ons sien hierdie projek as 'n belangrike mylpaal vir sosio-ekonomiese opheffing. Deur formele opleiding vir landbouwerkers beskikbaar te stel, kan ons nie net hul vaardighede verbeter nie, maar ook hul loopbaangeleenthede verbreed,” sê Cronjé.

Die Landelike Stigting het sy oorsprong in die Advance Network-inisiatief, wat sedert 2022 verskeie sewesrugby- en netbaltoernooie vir landbouwerkers in Stellenbosch en Tulbagh aangebied het.

As deel van sy langtermynstrategie is daar besluit om 'n netwerk met verwante organisasies te stig wat op sport-, sosio-ekonomiese en ekonomiese ontwikkeling in die landbousektor fokus.

“Ons het gesien watter positiewe impak sport op die landbougemeenskap het. Dit het ons geïnspireer om 'n breër netwerk op te bou met organisasies wat dieselfde doelwitte deel.

“Die uiteindelige doel is om die gemeenskappe waarin ons werk werklik te bemagtig,” het Cronjé benadruk.

Die vennootskap met I3A is een van die vernaamste inisiatiewe van die stigting en behels die vestiging van 'n satellietkampus in Kaapstad.

“Deur samewerking met I3A kry landbouwerkers toegang tot erkende opleiding, wat 'n belangrike rol in die volhoubare ontwikkeling van die sektor speel,” het Johann Stassen, besturende direkteur van I3A, tydens die bekendstelling gesê. Hy het ook besonderhede oor die aanvanklike vestiging van die kampus, die model vir die projek en die verwante koste verduidelik.

Benewens onderwys, bly sportontwikkeling 'n kernfokus van die stigting en word dit tans oorweeg om sokker as 'n sportkode vir landbouwerkers by te voeg.

Die Landelike Stigting het ook 'n vennootskap met die Mark Fish Foundation (MFF) aangegaan om MFF se suksesvolle "Fast Footy"-liga, wat tans in Limpopo bedryf word, na die Wes-Kaap uit te brei.

Volgens Cronjé is sport 'n belangrike instrument om gemeenskappe te verenig en talent te ontwikkel.

"Deur sporttoernooie te hou, bring ons nie net mense bymekaar nie, maar ons bou ook 'n gevoel van trots en samehorigheid onder landbouwerkers," het hy verduidelik.

Die Landelike Stigting se filantropiese fokus sluit ook fondsinsameling in, wat nie net die voortsetting van sportgeleenthede verseker nie, maar ook die moontlikheid bied om formele onderwys aan landbouwerkers beskikbaar te stel.

"Ons is opgewonde oor hierdie nuwe fase en glo dat ons werklik 'n verskil in mense se lewens kan maak," het Cronjé afgesluit.

# Goats of gold: Australia's feral goat problem has become a \$235m export trade

**Australia is the world's largest exporter of goat meat despite accounting for just 0.4% of total global production – and it's mostly from wild herds**

On a sprawling property in outback Australia, Nick Deshon and his team are drafting rangeland goats. The goats are a motley, multicoloured lot; some have beards, others sport mohawks or woolly mops, long hair or short. There are curved horns, tufty tails and soft eyes.

But this motley crew – born wild then rounded up – has helped make Australia the largest exporter of goat meat in the world.

Deshon and his sons, Tom, Harry and Jack, work on their 24,000 hectare (59,300 acre) property between Cumborah and Lightning Ridge in northern [New South Wales](#). They have been operating a goat depot since 2003, sourcing small numbers of feral goats from pastoralists from Moree to Gilgandra and collating them for transport to the abattoir in Bourke, where up to 3,500 can be processed daily.

In the heady days of 2021, goat prices at the abattoir peaked at \$10/kg carcass weight, before plummeting to \$2.40 at the end of 2023. "When there's no price, no one chases the goats," Deshon says. "At the end of 2023 there was not much coming in the gate, and we didn't have a lot of feed.

"Then it started raining and the price went up to \$3.20 and people started chasing them again.

Now we're back in the game, the feed is unreal, and the goats are pumping on weight."

Feral goats are found all over Australia, but western NSW is where they are most prevalent, with the last count, in 2020, estimating a population of 4.9 million. According to [Meat and Livestock Australia](#) 2,364,307 goats, worth \$235m, were slaughtered in 2023.

That's only 0.4% of global production, and domestically, the market is small. Just 9% of Australian goat meat is consumed onshore. The rest is exported: Australia produces 35% of all goat meat exports, and accounts for 44% of the

global export value of goat meat. Most is exported as frozen whole carcasses.

The biggest market is the United States, accounting for an average 60% volume share over the past five years. Goat, an affordable meat that has a low fat content, high iron levels, and no religious restrictions, is popular in Hispanic and Muslim communities.

Feral rangeland goats still make up the bulk of the market in Australia, through goat depots. Goat depots are collection points that allows operators like Deshon to bypass Australia's livestock tracing system and tagging requirements, provided the goat goes directly from the property of capture to a goat depot to an abattoir.

But farmed production systems are on the rise, encouraged by the NSW government, which recently invested \$1.2m into the industry through its [Going Ahead with Goats](#) project.

“Our goat producers in western NSW are at the forefront of the goat industry and the NSW government is supporting them with a number of resources so goat producers and stakeholders can take their goat business and the industry to the next level,” the NSW agriculture minister, Tara Moriarty, says.

But the Invasive Species Council has warned against increasing goat production, estimating that feral goats cause losses to livestock farming of \$25m a year.

“Goats are one of the worst invasive species because they stop regeneration of bushland, they overgraze [vegetation], they outcompete native animals and they erode soils and stream banks,” the Invasive Species Council's advocacy director, Jack Gough, says.

“They have been recognised under federal environment law as a direct threat to species on the brink of extinction and one of the emerging threats is the reduction of carbon storage due to their eating of woody vegetation.”

Kieran Smith is the goat adviser with NSW Local Land Services, the body responsible for the administration of the Going Ahead with Goats project. He says the damage caused by feral goats is not specific to goats – it would be a problem with any uncontrolled herbaceous animal.

“We work with landholders to manage total grazing pressure, which considers the number of domestic, native and pest species, to produce positive outcomes for the landscape,” Smith says.

Goats are well adapted to arid and semi-arid environments meaning farming requires little to no chemical inputs.

“They can also control weeds in the landscape and their production has considerable economic value for western NSW communities, not just the landholders but flow on effects from truck drivers to abattoir workers,” Smith says.

The main barriers to commercialisation of goats have been the lack of suitable infrastructure and the seasonal variation of the wild goat population. The Going Ahead with Goats program aims to upskill producers to improve productivity and profitability and research the development of sustainable genetic improvements, especially the introduction of Boer and Kalahari goats.

But Deshon is happy to remain harvesting the feral population. "Farmed goats need to be ear-tagged but if goats go straight to the abattoir you

don't need to tag," he says. "In a busy year I've processed up to 10,000 goats and tagging all of them would be a nightmare, plus there are safety issues handling the big billies. Ours is a low-cost operation and you can still make a bob out of it when the prices are low."

# Bogemiddelde reën vir noordooste van SA verwag

**Die Suid-Afrikaanse Weerdiens sê aangepaste weervoorspellings vir die tydperk Februarie tot Junie dui op bogemiddelde reënval vir die noordoostelike dele van die land.**

Die weerdiens sê dit is in direkte teenstelling met die vorige aanduidings en kan waarskynlik toegeskryf word aan die skielike styging in temperature in die ekwatoriale Stille Oseaan. Dit het 'n skerp toename in die moontlikheid van bogemiddelde reënval veroorsaak.

Ondergemiddelde reënval word oor die suidwestelike dele van Suid-Afrika verwag; dit is egter nog nie dié streke se reënseisoen nie en die weerdiens sê geen noemenswaardige uitwerking word verwag nie.

Minimum en maksimum temperature gaan tussen Februarie en Junie ook meestal hoër as die gemiddeld wees. In die suidelike kusgebiede gaan ondergemiddelde maksimum temperature egter na verwagting deur die somer voortduur.

Die weerdiens sê ook die El Niño- suidelike ossilasie (ENSO) het onlangs die El Niño-drempel oorgesteek en gaan na verwagting oor die volgende paar maande op dié drempel bly. Daar kan nog nie met sekerheid 'n voorspelling gemaak word nie, met verskeie internasionale modelle wat verskillende rigtings aandui – óf 'n versterking van die La Niña-staat óf 'n neutrale staat.

In Suid-Afrika moet daar steeds met groot waaksaamheid omgegaan word met die gebruik van ENSO in enige belangrike beplanningsbesluite; die weerdiens sê die

stelsel is steeds geweldig onvoorspelbaar en wisselvallig.

In Suid-Afrika, waar die somer nou geleidelik einde se kant toe staan, is daar boonop al hoe minder kans vir 'n moontlike La Niña-stelsel om enige uitwerking hier te hê.

## Water, krag


Die styging in temperature kan ook verlengde UV-blootstelling tot gevolg hê. Dit kan lei tot sonbrand en ander verwante probleme.

# Scientists study if goats and dogs can predict earthquakes and volcanic eruptions

A previous study in Sicily found that goats became nervous before an eruption at Mount Etna

**A team of scientists have begun exploring whether dogs, goats and other farmyard animals are able to predict natural disasters such as volcanic eruptions and earthquakes.**

They have enrolled thousands of animals for a programme that uses tiny transmitters fitted to mammals, birds and insects to monitor their movements from a satellite in space.

As well as analysing their reaction to imminent disasters, it will also study the spread of diseases among breeds, the impact of climate change and migration patterns.

A previous study in Sicily on the slopes of Mount Etna, an active volcano, found that sensors showed the goats became nervous before an eruption and refused to move to higher pastures.

“They know beforehand what is coming. We don’t know how they do it, but they do,” the project leader, Martin Wikelski, of the Max Planck Institute of Animal Behaviour in Germany, told The Guardian.

“Ultimately, we hope to launch a fleet of around six satellites and establish a global observation network that will not only provide details of wildlife movements and animal health across the planet but reveal how creatures respond to natural phenomena like earthquakes,” he said.

It remains unclear why animals behave this way, with Mr Wikelski suggesting that the movement of tectonic plates throwing “ions from the rocks into the air” could be causing their reaction.

Tagging technology has made it easier for scientists to monitor animal behaviour, with tiny digital transmitters collecting data that can be analysed.

For example, an electronic ear tag placed on a wild boar has helped show the quick spread of the highly contagious African swine fever between them and domestic pigs.

It should also help scientists under migration, and why creatures such as death-head hawkmoths travel 2,000 miles between Europe and Africa every year.

“Similarly, we will be able to study animal populations to determine how they are responding to habitat changes triggered by global warming,” said Wikelski.




# Lewendehawe verander met tye



**Enige smous kan diere skuif, maar die bedryf stel vandag meer verwagtinge aan agente en daarom bied elke OVK bemarkingsadviseur die nodige ondersteuning aan die teler of produsent.**

Ons bemarkingsadviseurs neem ook deel aan al die kursusse wat die telersgenootskappe aanbied, wat keuring van bulle en beoordeling insluit en hulle leer sodoende die ras in diepte ken. Dit is wat die bemarkingsadviseur kwalifiseer om saam met die boer die volgende veiling se

aanbod te kan beplan en bestuur. Dit sluit in voeding, gesondheid en toetse soos vrugbaarheid en dragtigheidsstatus.” Benewens die aanbod is die tweede been in ’n veilingaanbieding die bemarking. “Die dae is verby waar jy net ’n advertensie in die Landbouweekblad kon plaas en die kopers daag op. Vandag het ons ’n baie langer aanloop tot en met die veiling deur aksies op bv. sosiale media te loods en bewustheid te skep. OVK Lewendehawe se bemarkingsadviseurs is almal by APAC geregistreer en tree volgens die voorgeskrewe reëls van APAC op.”

OVK se Lewendehawe-afdeling is 'n paar jaar gelede ontwikkel toe OVK by CMW betrokke geraak het en die afdeling het intussen tot nasionale verteenwoordiging gegroei in die groot- en kleinveesektore. “Lewendehawe tree ter ondersteuning vir die ander bedryfsareas soos handel, meganisasie en versekering op,

om uiteindelik 'n omvattende diens aan die boer te kan lewer.” Tans word streekskantore vanuit Swellendam, Cradock, Aliwal-Noord, Ladybrand, Hopetown en Standerton bedryf. Elke streekskantoor het 'n bestuurder en 'n span adviseurs wat onder meer hand-tot-hand verkope hanteer asook die aanbieding van weeklikse en maandveilings, boereverenigingsveilings, produksie- en stoetveilings, spesiale veilings soos staakveilings en geregtelike veilings.

Die OVK Lojaliteitskema is ook van toepassing op OVK Lewendehawe en bona fide boere ontvang maandeliks 'n lojaliteitsvoordeel op die bruto winsbedrag van hul transaksies wat by OVK gedoen word. Sodra ons ons eie biosekuriteit en naspeurbaarheid in plek kry, is dit in die hande van die boer en iemand soos 'n OVK om self uitvoergeleenthede te skep. Saoedi- Arabië is 'n voorbeeld van 'n potensiële mark wat suksesvol ontgin is.”

Johan sien klimaatsverandering en die aanpassing daarby as die grootste uitdaging vir die lewendehawebedryf. “Die telersgenootskappe se beleide sal suiwer moet wees en voorsiening maak dat hulle diere vir die toekoms teel wat goeie hitte-uitruiling het en aanpasbaar is by die veranderde klimaat in spesifieke streke van die land wat warmer word. Hierdie diere sal dan ook in die veranderde klimaat moet kan produseer. Indien dit nie gebeur nie, gaan die ras uitsterf.



# 7 poultry rules for your farm



**Do you have passion for poultry and really wish to stay long in the business? Then obey these rules**

## **1. Only order for birds you can conveniently take care of this is the most important rule of all**

Instead of sticking 500 birds and the struggle to feed them or give them medication. Buy 200 .feed and give them good medication.

Trust me you'll make more profit than keeping 500 and struggling to feed and give the medication. If this happens. You'll battle with stunted growth recurrent morbidity or diseases outbreaks and high mortality

## **2. Never borrow money to start poultry business unless you are an expert**

Of course. There is no expert in poultry business in fact. We learn everyday every stock you take in will always teach you something different. However. Haven learn from all the different characteristics displayed by each stock. You get to know more and won't be excited when challenges come. You'll know how to handle them without much damage

## **3. Be vigilant**

The little thing you don't take as anything matters if you want to succeed in poultry. You must take it as a really business. Do you know what a

business man does every morning when he gets to his store. He prays. Then open the store and go around to check if everything is in its place he take stock of what he met there and relate with his record yesterday before closing the store. Don't just open your pen and start rushing to give your birds feed and water and rush out again. Check around, watch how they behave when you come in. Check what fell and what is no longer in it's place.

## **4. Never ignore warning signals**

Yes I call them warning signals

1. bad smell
2. withdrawal from feed
3. Moodiness
4. Withdrawal from water

There are numerous warning signals I can't mention here .in fact they are so many.

A farmer must know how his birds behaves when they see him enter the in the morning. How they behave when he serves them feed. He should know the very active terrors and gentle lambs

If you keep these signals. You'll easily spot when something is not right

## 5. Never change feed indiscriminately

I know you do this. When farmer's talk about changing feed from this to this and that then this all in the name getting better results. I'm always scared for them.

Whether you are changing from a bad feed to a good one. You must be very careful.

Do you know every change in feed affects your bird negatively first before gradually bringing in the results you don't desire? Most of the time you may suffer withdrawal. Coccidiosis, feed wastage. Stress and more

Imagine changing from mash to pellets indiscriminately. Do you know what that means? Have you studied the difference between mash and pelleted feed and the process of digestion?

They may contain the same ingredients but the formulation process varies so is the digestion process

**Note:** I don't mean changing from starter to grower or finisher. But changing from one commercial feed to another. e.g change from chicken/ alam to other brands.

Whenever you need to change from starter to grower follow the rules 75% starter and 25% grower. 50% grower and 50% starter and finally 75% grower and 25% starter. At the end you change 100% to grower feed. You can follow the same rule whenever you need to change from one phase feed to other. This one works for feed of the same brand too.

Each company uses their own unique ingredients to make their feeds although they may give the some nutritional content. Before using any feed for birds. Find out first about the feed and make sure you stick with it

## 6. Never let your birds run dry of water

Have you heard of heat stress? If it has happened to your birds then you'll understand what I'm saying.

Heat stress can wipe your entire flock, and it may leave your birds vulnerable to all kinds of infections as their immune system get weakened and may take more than 14 days to fully recover.

Your birds can survive 48 hours without feed but they can't survive 7 hours without water. Instead of running out of water. Please run out of feed

## 7. If you can't drink that water don't give it to your birds

Some farmers treat chickens as if they are just animals and nothing matters. Maybe they're forgotten they are dealing with delicate live animals.

Waterborne diseases are some of the deadliest disease and most difficult to control. Imagine a tiny drop of harmful substance inside the drinking water. It'll contaminate the whole water. If it was feed it may not be that bad please. If you can't drink that water don't give it to your birds. I'm not talking about medication water.



# Babesioses in beeste – Die Twee Rooiwaters



Erge bloubosluislading

## Inleiding:

Bosluisoorgedraagde siektes veroorsaak groot ekonomiese verliese vir beesprodusente in Suid-Afrika. Babesiose, meer algemeen bekend as Rooiwater by beeste, is 'n bosluisoordraagbare siekte wat veroorsaak word deur 'n protosoale parasiet genaamd *Babesia*. Daar is twee onderskeidende tipes rooiwatersiektes in Suid-Afrika, naamlik Afrika rooiwater en Asiatiese rooiwater. Afrika rooiwater word deur *Babesia bigemina* veroorsaak en Asiatiese rooiwater word deur *Babesia bovis* veroorsaak. Siekteverspreiding, vektoroordrag en in sommige gevalle kliniese tekens en uitkoms verskil tussen hierdie twee siektes.

## Siekteverspreiding, vektore en oordrag:

Rooiwater is 'n bosluisoordraagbare siekte wat beteken dat bosluis die primêre vektore is wat die siekte oordra. Daarom sal die siekte voorkom waar ook al die bosluisvektore voorkom.

Afrika-rooiwater kan deur beide Afrika-bloubosluis (*Rhipicephalus (Boophilus) decoloratus* en Asiatiese-bloubosluis (*Rhipicephalus (Boophilus) microplus*) oorgedra word, asook eksperimenteel deur 'n tweegasheerbosluis, naamlik die Rooipootbosluis (*Rhipicephalus evertsi evertsi*). Asiatiese rooiwater word slegs deur die Asiatiese-bloubosluis (*R. (Boophilus) microplus*).


Bloubosluis is eengasheerbosluis wat hoofsaaklik op vee parasiteer.<sup>1</sup> Die Afrika-bloubosluis kan egter ook op wild parasiteer.<sup>1</sup>

Dit is belangrik om die lewensiklus van die eengasheerbosluisspesie en die oordrag van Rooiwater te verstaan. Die lewensiklus van 'n eengasheerbosluis bestaan uit vervelling van larwe tot nimf en nimf tot volwassene alles op een gasheer.<sup>1</sup> Hierdie lewensiklus is baie kort en die hele lewensiklus kan binne 21 dae voltooi word.<sup>1</sup>

Die oordrag van Afrika-rooiwater en Asiatiese rooiwater verskil deurdat Asiatiese rooiwater deur die larf-, en volwasse stadiums oorgedra kan word, terwyl Afrika-rooiwater slegs deur die nimf- en volwasse stadiums oorgedra kan word. Dit het implikasies wanneer 'n bosluisbeheerstrategie geïmplementeer moet word om 'n uitbreking van Asiatiese rooiwater te beheer.

Die Afrika-bloubosluis het 'n wyer verspreiding in Suid-Afrika wat deur die meeste van die klam streke en koue bergagtige streke soos die Drakensbergreeks strek.<sup>1</sup> Dit is afwesig in dele van Suid-Afrika met 'n gemiddelde jaarlikse reënval van minder as 380 mm, insluitend die Wes-Vrystaat, en die westelike streke van die Noord-Kaap Provinsie.<sup>1</sup> Die Asiatiese-bloubosluis het 'n beperkte verspreiding met verspreide gebiede langs die suidelike en oostelike kus van die Wes- en Oos-Kaap provinsies en van KwaZulu-Natal sowel as verspreide gebiede van Mpumalanga en Limpopo provinsies.<sup>1</sup>

Die Asiatiese-bloubosluis brei egter uit in sy verspreidingsgebied as gevolg van die indringing



van hierdie bosluise na ander gebiede en kan in sommige gevalle die Afrika-bloubosluis vervang.<sup>1</sup> Dit kan op verskeie maniere gebeur, wat die vervoer van diere of plantmateriaal soos grasbale insluit wat besmet is met Asiatiese-bloubosluis van een streek na 'n ander waar hierdie bosluise nie normaalweg voorkom nie. Veeprodusente moet dus streng biosekuriteitsprotokolle implementeer om die bekendstelling en uitbreiding van die verspreidingsgebied van die Asiatiese-bloubosluis te probeer voorkom. Hierdie protokolle sluit in om te verseker dat beeste behandel word met 'n doeltreffende bosluisbeheermiddel (dip) voordat hulle vervoer word en die keuse van bronne van grasbale uit gebiede wat 'n laer risiko inhou om Asiatiese-bloubosluis te bevat. Uitdagings vir beesprodusente vir hierdie implementering van biosekuriteitsprotokolle sluit in weerstand teen bosluisbeheermiddels en beperkte bronne van grasbale, veral tydens katastrofiese droogtetye.

### Kliniese tekens van siekte:

Die inkubasietydperk vir rooiwater is baie kort, tussen 8 – 15 dae,<sup>2</sup> wat beteken dat 'n bees kliniese tekens kan begin toon kort nadat 'n bosluis die dier gebyt het en met die *Babesia*-parasiet besmet geraak het. Die tipiese kliniese tekens van Rooiwater sluit 'n dier in wat lusteloos is, nie eet nie (anoreksie), koors en bleek slymvliese het (aanduiding van bloedarmoede). Met Afrika-rooiwater kan effense geel slymvliese (ikteries) opgemerk word in meer sub-akute tot chroniese gevalle. Asiatiese-rooiwater kan manifesteer as skielike sterftes waar geen kliniese tekens opgemerk word nie. In sommige gevalle van Asiatiese rooiwater kan neurologiese tekens ook in beeste gesien word. Daaglikse waarneming en die gebruik van 'n termometer om die diere se temperatuur te meet is noodsaaklik om enige dier wat tekens van Rooiwater toon vroegtydig te identifiseer sodat behandeling stiptelik toegedien kan word.

### Die hantering van 'n Rooiwater-uitbraak:

Rooiwater uitbrake kom gewoonlik skielik voor, met die hoogste risikoperiodes wanneer bloubosluisgetalle uiters hoog is. Hoë bloubosluisgetalle kom gewoonlik gedurende die laat somer tot herfs seisoene voor. Eerstens is dit belangrik om te onderskei tussen Afrika-rooiwater en Asiatiese-rooiwater. 'n Veearts kan 'n diagnose maak gebaseer op die ligging, die geskiedenis, kliniese tekens, 'n bloedsmeerondersoek om die spesifieke *Babesia*-parasiet te identifiseer en op nadoodse bevindings. Die volgende stap om uit te voer is om al die beeste met 'n doeltreffende bosluisbeheermiddel te behandel. Beeste moet een keer per week gedip word in die geval van Asiatiese rooiwater en een keer elke tweede week in die geval van Afrika rooiwater, om verdere oordrag van die siekte deur die bosluise te voorkom. Verskeie behandelingsprotokolle kan gevolg word gebaseer op die advies van die Veearts wat blokbehandeling van kuddes met óf diminasien óf imidokarb insluit.

### Uitbrake van Rooiwater kan voorkom as gevolg van verskeie redes. Voorbeelde sluit in:

1. die inbring van vatbare beeste, dit wil sê beeste wat nie immuniteit teen rooiwater het nie, op 'n plaas waar rooiwater endemies is.
2. waar bosluisvektore per ongeluk ingebring is op 'n plaas waar rooiwater nie endemies is nie en daaropvolgende uitdaging van vatbare beeste met die bosluisvektor en rooiwater.
3. waar diere in 'n rooiwater endemiese gebied nog nooit beskermende immuniteit ontwikkel het nie en skielik deur hoë bosluislading en rooiwater uitgedaag word.
4. waar diere onder stres verkeer en hulle immuunsisteem onderdruk is.

### Bestuur van endemiese stabiliteit en immuniteit:

Strategieë om rooiwater te bestuur is plaasspesifiek en sal afhang van die voorkoms van die tipe rooiwater. Endemiese stabiliteit verwys na 'n situasie waar die bosluislading voldoende is om te verseker dat beeste aan die *Babesia*-parasiet blootgestel word om die ontwikkeling van immuniteit te verseker, sonder om enige negatiewe effekte te veroorsaak wat met hoë bosluislaste geassosieer word. Kalwers het ingebore immuniteit tussen 3 – 8 maande

oud en moet ideaal gesproke aan 'n voldoende bosluislading blootgestel in hierdie tydperk word om uitdaging en daaropvolgende immuniteit te verseker. Bloedentstowwe is beskikbaar vir die immunisering van beeste met óf Afrika- en Asiatiese rooiwater. Kalwers kan binne hierdie tydperk geïmmuniseer word om beskermende, relatief langdurige immuniteit teen die spesifieke tipe rooiwater te stimuleer. Ideaal gesproke moet beeste dan aan genoeg bosluisvektore blootgestel word om voortdurend die immunstisteam te stimuleer en langdurige immuniteit te verseker. Die bestuur van Asiatiese-rooiwater is veral uitdagend weens die beperkte verspreiding van die bosluisvektore en siektevoorkoms. Beeste word nie voldoende blootgestel nie en endemiese stabiliteit word nie maklik gevestig nie.

Die inbring van vatbare beeste in 'n rooiwater endemiese streek vereis die bystand van 'n Veearts. Daar is verskeie strategieë wat gebruik kan word, insluitend immunisering met behulp van bloed-entstowwe en daaropvolgende behandeling wanneer diere 'n koorsreaksie ontwikkel om immuniteit te vestig, behandeling met diminasien of imidokarb, en waarneming en bosluisbeheerstrategieë.

Die belangrikheid van die Kuddegesondheidsveearts om te help met die hantering van siekte-uitbrekings en die bestuur van rooiwater is noodsaaklik en dit word aanbeveel om met hul te konsulteer en kundigheid gebruik te maak.

### **Belangrike punte - Asiatiese rooiwater:**

- Asiatiese rooiwater is 'n dodelike siekte en beeste kan skielik vrek sonder om kliniese tekens te toon.

- Daaglikse waarneming is belangrik om tekens van siekte vroeg raak te sien sodat behandeling so gou as moontlik toegedien kan word.
- Die verspreiding van die Asiatiese-bloubosluis, die vektor vir Asiatiese rooiwater, is beperk tot spesifieke streke, maar dit brei uit en word in nuwe gebiede ingebring, wat beeste affekteer wat geen immuniteit teen Asiatiese rooiwater het nie.
- Die lewensiklus van die Asiatiese bloubosluis is kort en die bosluispopulasie kan vinnig vermeerder.
- Asiatiese rooiwater word deur die larf-, nimfe- en volwasse stadiums van die Asiatiese-bloubosluis oorgedra. Afhangende van die bosluisbeheerstrategie (aktiewe bestanddeel, produkformulering en dipinterval), kan die oordrag van Asiatiese rooiwater in 'n relatief kort tydperk plaasvind nadat bosluisbeheer toegepas is.
- Raadpleeg jou Kuddegesondheidsveearts oor die hantering van 'n rooiwater uitbraak en toekomstige bestuurstrategieë.

## FEEDING Hay

Hay is the traditional diet for sheep/goats during the winter months and/or in confinement. It is also commonly fed to grazing animals, especially during drought or other periods of inclement weather. Hay can be a substantial part of the feed budget, especially if it has a high opportunity cost or must be purchased. Storage losses and feed wastage also factor into the cost of feeding hay.



Hay can vary significantly in quality and should be tested. If you don't know the nutritive content of your hay, you won't know what (or how much) you need to supplement in the diet of your animals




### Some ways to reduce hay cost

- Harvest hay properly
- Store hay properly
- Feed good quality hay
- Chop low quality hay or incorporate it into a TMR
- Always feed hay in feeders
- Limit feed hay; make animals clean up what you feed.



Hay bales vary considerably in weight. You need to feed and purchase hay by weight. If hay is sold by the bale, be sure to weigh some representative bales so, you know how much you are paying (and feeding). Hay prices are usually reported on a per ton basis.

For some farms, it may be more economical to feed diets that contain less hay, though some long stem forage is always recommended in ruminant diets.







Australia is a world leader in the processing and preparation of halal meat and meat products.

The involvement and expertise of the Islamic organizations registered to supervise and certify the production processes ensure each company has documented procedures and processing requirements implemented at all production stages.

Processors must have a registered Halal program which complies with Australian Government Authorized Halal

Program (AGALP)—a collaborative program between Islamic Societies and the Australian government) requirements.

Facilities inspected and accepted for Halal slaughter and/or production. The inspections are carried out by recognized Islamic organizations and the Australian Quarantine and Inspection Services (AQIS).

Processors must only employ Muslim slaughtermen.

Halal and non-Halal beef, lamb and goat must be separate and identified at all times.

Halal meat is identified by an official halal stamp to carcasses or products in a carton.

For all exports, only recognized Islamic organizations can certify halal meat and meat products.

Halal meat must be described on the Meat Transfer Certificate used by export companies when transported between export establishments.

Halal meat for final export receives an official halal meat certificate signed by both AQIS and a recognized Islamic Council representative.
